Transportation Facility Norms

- » BGC moves the college buses only on main road and not inside the city or village.
- » For transportation fee, Kms will be counted from city to campus, not from the city to Sardulgarh.
- » No student will be allowed to take bus service without bus pass.
- » Transportation charges may be revised at any time.
- » Any damage to bus done by the student is a punishable offence.
- » Route can be changed any time.
- » If, while traveling in the bus any student or other occupants any injure or lose of property or life, the College authority and management shall not be held liable for the same.
- » In any such case, the parents or guardian shall not claim any compensation from the college management. However, the insurance company may be held liable for the same.
- » It shall be the duty of parents to look after the safety and security of their child. In case the student is found careless and negligent while traveling in the bus, he may be stopped from traveling in the bus.
- » In such case if the driver is found careless or negligent, proper action shall be taken against the driver.
